### Submission Process:

**-All work must be hand delivered on receiving dates.**

**-All work must be labeled on the back with title, medium, price and artist's name.**

### Requirements:

Artists are invited to submit three pieces of artwork. **The exhibition is open to all mediums.**

### Framing Information & Instructions:

**All entries *must be framed and wired on back or canvas not framed must have painted edges.***

Damage occurring because of improperly wired works will not be insured. Works matted and on paper must be framed and covered with glass or plexiglass **or they will not be insured.**

***The following will NOT be accepted:***

-sandwich frames (2 pieces of glass or plexiglass joined by clips.)

-alligator clips/zig-zag hangers at top of frame

-table top frames

### Size Requirements:

Maximum framed size: 50" x 50"

Artwork submitted may be used for advertising purposes. The artist will be credited.

### Sales:

Artists set the retail price for their artwork and will receive 65% of the retail price on all sales. Perkins will receive 35%.

### Opening Reception:

Saturday, November 16, 2024 from 2-5pm

Free and open to the public.

We are not responsible for minor scrapes or scratches on frames or broken glass which exceeds the maximum framed size. By entering this exhibition you agree to any and all terms and conditions.
